ROLE OF STAKE HOLDERS

1. Farmers are to register their names and area to be covered under the programme.
2. Farmers have to follow all the instruction with regard to crop improvement.
3. The land of the farmers has to be close to the lift Irrigation point of the foundation.
4. The farmers must have to pay the operational cost of machineries and other inputs such as seed, pesticides etc.
5. The farmers must have to engage their own labour to carry out the field operations.

ROLE OF SAVITREE FOUNDATION IN INTESIVE AGRICULTURAL
DEVELOPMENT PROGRAMME **AT**
VILLAGE – CHAMPATI

1. Provide all technical information with regard to cropping pattern and monitoring of crop health at 15 days interval
2. Provide irrigation system at field points.
3. Facilities seedling rising at one point.
4. Provide mechanical support such as tractor, cultivator, rotavator , sprayers, thrashers etc at no cost no profit basis.
5. Procurement of seeds and pesticides and supply to famers at no cost no profit mode.
6. Facilitate provision for concrete thrashing floor with partial covering for harvesting of produce.
7. Purchase of produce of the stake holders at a rate of whole sale price existing in the precious day or as per rate available in interest.
8. Develop market link for sale of the collected produce.

9. Conduct meetings of farmers to discuss on various problems at 15days interval.

10. Provide financial support with regard to payment of premium towards crop insurance.
